Contributor Biographies

John Baesch, ASH, BSI (State and Merton Railway) grew up in Baltimore, MD. He first met Sherlock Holmes in the ninth grade at Loyola Blakefield, Baltimore’s Jesuit high school. John attended Loyola College in Maryland, receiving an AB with concentration in Classics and an Army commission. In Vietnam, his military specialty was transportation and logistics—skills that helped him in his later occupation and avocation. He worked 30 years in railroad operations, starting with the C&O/B&O Railroads and subsequently 25 years at Amtrak. John received his BSI shilling in 1999. He is married to Evelyn Herzog (“The Daintiest Thing Under a Bonnet”). They live in Baltimore and support Watson’s Tin Box and other Eastern scions.

Phillip Bergem, BSI (“Birdy Edwards”) lives in Andover, Minnesota, a suburb of Minneapolis, where he stays busy with a number of Sherlockian and Doylean projects. In his spare time he works as a Civil Engineer with the Minnesota Department of Transportation. His areas of specialized interest include the *Strand Magazine* and the family history and writings of Arthur Conan Doyle. This is the fifth Doyle manuscript that he has annotated with John Bergquist. Phil has been a member of the Norwegian Explorers of Minnesota since 1993.

John Bergquist, BSI (“The King of Scandinavia”) is Co-Publisher and Production Editor of Baker Street Irregulars Press, the book-publishing venture of the BSI – including the Manuscript Series. He received the BSI’s Two-Shilling Award in 2010. He has long been active in the Norwegian Explorers of Minnesota, having served as co-leader of its study group and as editor of its newsletter, *Explorations*, and of its *Christmas Annual*. He also serves as Vice President of the Friends of the Sherlock Holmes Collections at the University of Minnesota (his alma mater) and is on the editorial board of its newsletter.

Andrew G. Fusco, BSI (“Athelney Jones”) was invested in 1972 and is the current General Editor of The Baker Street Irregulars Manuscript Series; this volume is the fourth under his tenure. The first was *So Painful a Scandal*, edited by John Bergquist and published in 2009. Mr. Fusco’s first published Sherlockian work appeared in *The Baker Street Journal* in 1969, and he has been an avid student of the Canon, commentator and collector for more than 40 years. A practicing attorney in Morgantown, W.V., he has served as informal legal adviser to the last three leaders of the BSI. He is a member of numerous Sherlockian societies, including The Scion of the Four, in which he has served as Commissionaire since 1971.

Paul H. Haagen is Professor of Law and Associate Dean for International Initiatives at Duke University School of Law. He is also Faculty Director of the Asia America Institute in Transnational Law in Hong Kong and Director of Duke Law’s Center for Sports Law and Policy. Professor Haagen did his BA at Haverford College in Religion (Class of 1972, along with Bob Katz), a BA and MA in Modern History at St. John’s College, Oxford, where he was a Rhodes Scholar, a PhD in History at Princeton University and a JD at Yale Law School. Before joining the Duke faculty in 1985, he clerked on the United States Court of Appeals for the Third Circuit and practiced law at Dechert Price and Rhoads in Philadelphia. His scholarly writing is principally in legal history, international arbitration and sports and the law.

Robert S Katz, MD, ASH, BSI (“Dr. Ainstree”) received his BA from Haverford College (where he and Paul Haagen were members of the Class of 1972) and his MD from The Albert Einstein College of Medicine. He resides in Morristown, NJ and recently retired after thirty-five years of practicing Pathology. He has been a Sherlockian for longer than he can remember, receiving the Irregular Shilling in 1983 and the Two-Shilling Award in 1995. His articles have appeared in numerous Sherlockian publications, and he has been a speaker at many scion society and BSI dinners. He was a co-editor of the BSI Manuscript Series book on “The Golden Pince-Nez,” *The Wrong Passage* (with Andy Solberg). He has been active in many of the scion societies on the East Coast, served as Gasogene of the Six Napoleons, is the current Headmastiff of The Sons of the Copper Beeches, and founded The Epilogues of Sherlock Holmes in New Jersey in 1990.

Rodney McCaslin co-founded the scion society Watson’s Tin Box in Ellicott City, MD with Steve Clarkson and Paul Churchill. As an historian, he specializes in the study of intelligence and travel writing in the British Empire and writes book reviews for *World History Connected* and *Reviews in History*. He teaches World and European history at Centennial High School in Ellicott City, occasionally guest lectures on the history of imperialism, the Great Game, and the career of Sidney Reilly at the Institute of World Politics in Washington, D.C., and serves as historian of the St. Andrews Society of Baltimore. Presently, he is also engaged as a perpetual PhD. Candidate in policy history at the University of Maryland, Baltimore County.

Glen Miranker, BSI (“The Origin of Tree Worship”) retired from Apple Computer, where he was Apple’s Chief Technology Officer (Hardware), and now lives in San Francisco. His collection includes ephemera, manuscript material, artwork, first editions, recordings, canonical writings, pirated editions, a Charlie McCarthy (as Sherlock) sugar spoon and a notebook where Arthur Conan Doyle scribbled the words, “Killed Holmes.” Glen is a member of The Friends of Irene Adler and The Speckled Band of Boston and is a founding member (and ex- Co-Chairman) of The BSI Trust. Glen has given many talks about book collecting, Sherlock Holmes and Arthur Conan Doyle to the Grolier Club, the Roxburghe Club, the University of Minnesota Library and the Toronto Reference Library, among others.

Elizabeth L. (“Betsy”) Rosenblatt, ASH, BSI (“Lucy Ferrier”) lives in Los Angeles. She is a professor at Whittier Law School, where she teaches intellectual property law subjects and directs the school’s Center for Intellectual Property Law. She received her B.A. from Williams College and her J.D. from Harvard Law School. Betsy inherited her love of the Canon from her parents, and is a lifelong Sherlockian, belonging to The Baker Street Irregulars, Adventuresses of Sherlock Holmes and several other Sherlockian organizations.

Constantine Rossakis, MD, BSI (“St. Bartholomew’s Hospital”) is a cardiologist in private practice in Bergen County, New Jersey. He received a BA in both Biology and Psychology (Magna Cum Laude, Phi Beta Kappa) from New York University and his MD from The New York University School of Medicine (Alpha Omega Alpha). He is perennially recognized (in *The New York Times*, *U.S. News and World Report*, *New Jersey Magazine*, *Castle Connolly*, and others) as a top U.S. Cardiologist. He is a member of The Grolier Club, and has published numerous articles in both medical and Sherlockian fields. He was the recipient of the 2004 Morley-Montgomery Award and is a founding member (and ex- Co-Chairman) of The BSI Trust. The focus of his library is Sherlockian source material (manuscripts, first appearances and editions, notebooks), which serve as fodder for describing heretofore undiscovered editions of the Canon, including, most recently, the determination of the true first issue of the 1887 *Beeton’s Christmas Annual*.

Steven Rothman, BSI (“The Valley of Fear”) has edited *The Baker Street Journal* since 2000 and holds the Two-Shilling Award. He writes and talks about the works of Christopher Morley and edited *The Standard Doyle Company: Christopher Morley on Sherlock Holmes* (1990) and “A Remarkable Mixture”: *Award-Winning Articles from The Baker Street Journal* (2008). He co-edited with Nicholas Utechin, the former editor of *The Sherlock Holmes Journal*, *To Keep the Memory Green: Reflections on the Life of Richard Lancelyn Green, 1953–2004* (2007). He delivered the 2008 Cameron Hollyer Memorial Lecture to the Friends of the Arthur Conan Doyle Collection of the Toronto Public Library. A dedicated book collector since the age of twelve, he is also the President (apparently for life) of the Philobiblon Club of Philadelphia

Andrew Solberg, ASH, BSI (“Professor Coram”) received a BA in Philosophy from Brandeis University and an MHS in Health Planning and Administration from the Johns Hopkins School of Public Health. He lives in Maryland and operates a strategic planning consulting practice for healthcare providers. He has been a healthcare regulator and an adjunct faculty at the Johns Hopkins School of Public Health. He has published more than 25 Sherlockian articles, including a Morley-Montgomery Award winning article in 2003 (with Donald K. Pollock), and co-edited *The Wrong Passage* (with Bob Katz). A former Gasogene of Watson’s Tin Box and a member of many other Sherlockian groups, he also is the newly appointed Chairman of the BSI Trust.

Randall Stock, BSI (“South African Securities”) is a product marketing consultant in Silicon Valley and has presented papers on rare Conan Doyle material at Harvard’s Conan Doyle Symposium and at the University of Minnesota. He has written extensively on the subject, including manuscript histories for three prior volumes in The Baker Street Irregulars Manuscript Series. His website, The Best of Sherlock Holmes <www.bestofsherlock.com>, provides news and information about rare Sherlockiana. Randall manages the websites for the *Baker Street Journal* and the BSI Trust and is the newly appointed Director – Technology for the BSI.

William Walsh graduated from Haverford College in 1984, as a member of the College’s first co-ed freshman class, and from the University of Minnesota Law School. Will credits his father with first introducing him to Basil Rathbone and Sherlock Holmes, and Will has spent the last twenty years attempting the same indoctrination on his wife Marion and their four children (with varying results). When not working as an environmental litigator, Will serves as the treasurer of both the Gaslight Gala and the Lincoln Society of Peekskill and challenges Sherlockians as the quizmaster of the Three Garridebs..
